ONE-TIME DONATIONS:

One-Time Donation to Sana'a (father of 6 girls)

- This donation was sent in April where Sana'a volunteers have since delivered it to the beneficiary.
- Donations were used to start a grocery shop from which the family was able to receive a steady income.
- The father was informed that the donation is a loan to be paid back on a monthly basis (5,000 10,000 rials). Once it's paid back, the Sana'a volunteers will donate back to him as reinvestment in his shop.

One-Time Donation to Sana'a - Grocery Store Debt

- This donation was sent early June (\$614.80 CAD + \$17.30 CAD in transfer fees) to a beneficiary (family man) to relieve him of his debt.
- In addition to having a family of his own, the beneficiary supports the kids of his two late brothers.
- The beneficiary had opened a grocery store by taking a loan from someone.
- His debt amounted to 400,000 rials, and his creditor has been blackmailing him into either paying off the debt or giving him the store he had opened.
- With your donations in addition to other donations collected by Sana'a volunteers, the beneficiary was able to fully recover from debt.

The Baqi Family – Status Update

- The family's finances have been stable. The propane tanks project and sewing has allowed them to become financially self-reliant.
- This was the first year since Mr. Baqi's illness that the family was able to purchase Ramadan's
 food rations and clothing without any financial aid. They were also able to purchase a new
 stove.
- Unfortunately, Mr.Baqi's medical condition has deteriorated.

MONTHLY ALLOWANCES:

May donations have been received and delivered to three families:

Family 1: Mr. Hubabah

- The family mainly used the donations to buy food.
- Due to the size of the family, there wasn't enough to save for setting up a source of income.

Family 2: Kifaiah Haddad

• She used a portion of the monthly allowances to cover the expenses of her recurring dialysis. She saved the remaining portion for other medical expenses and living needs.

• She recently had an eye surgery and was able to use a portion of what she'd saved to cover some of her expenses.

Family 3: Miss Thabet

• The family used the monthly donations to cover their daily basic needs. For example, the donations allowed them to purchase propane tanks for cooking instead of collecting wood.

REMAINING DONATION:

There remains 24,600 rials in Marsilya's possession:

- Marsilya has been unable to contact the girl in fear that her family may accuse Marsilya of interfering.
- Marsilya will wait until schools reopen to pre-pay the school canteen for meals.
